### **WELCOME**

# IT IS OUR PLEASURE TO WELCOME YOU TO THIS WORKSHOP ON THE U.S.-AUSTRALIA ALLIANCE FOR NEXT GENERATION LEADERS IN PERTH.

This workshop is part of a two-year program that involves three regional workshops to be held in Perth, Brisbane and Adelaide in 2020–2021. These workshops seek to engage young professionals in Australia with the potential to be the next generation of alliance leaders. We are looking for participants who will help shape the future of U.S.-Australia relations in the Indo-Pacific century. A select group from the regional workshops will have the opportunity to proceed to a national workshop in Canberra in 2021, and from that cohort, a final group will be chosen to attend a capstone workshop in Washington, DC.

The program introduces a group of about 55 young professionals to a range of alliance issues through workshop sessions, led by established academics and policymakers. Each workshop involves detailed discussions and presentations on topics such as:

- Shared values and democratic principles
- U.S.-Australia strategic relations
- Regional geopolitical issues and emerging security challenges
- U.S.-Australia cooperation on trade and economics
- Broader bilateral cooperation

The last two sessions in each workshop focus on producing a joint statement to be issued by the participants that will focus on current and future issues for U.S.-Australia cooperation in the Indo-Pacific region. These statements will help guide and inform the discussion and sessions in the Canberra-based workshop.

These workshops come at an important time for the U.S.-Australia alliance. The depth of cooperation and agreements between the two countries has never been greater, and the Alliance now arcs well beyond the traditional areas of intelligence and security cooperation encompassing: trade and economics, shared values and people to people contacts. We live, though, in challenging geopolitical times. Terrorism persists and conflict in the Middle East is ongoing.

Revisionist powers are challenging the existing international order while 'the West' seems beset with its own problems from challenging economic conditions, domestic upheaval and the ongoing implications of COVID-19. In the Indo-Pacific, the rise of China has opened up major economic opportunities, while presenting new challenges to the rules-based international order and U.S. hegemony in the region. Australia has benefited enormously in economic terms from China's rise, while at the same time meeting new challenges in the face of shifting regional power. As one recent Australian prime minister noted, Australia's policies towards China are driven by two emotions: fear and greed.

Many of these issues are playing out in contemporary Australian debates, with a range of major political and industry figures calling for a more 'independent' Australian foreign policy, while others are pushing for deeper ties with Australia's traditional partners and allies. Lowy Institute opinion polling shows the Australian public is highly attuned to international debates and their impact on Australia. This era has raised new questions about the future of the U.S.-Australian alliance in domestic, bilateral and international contexts, highlighting the increasingly complex and multifaceted challenges both countries face. For these workshops, we have brought together a range of key thinkers on regional security, economic questions and the U.S.-Australian alliance to address these issues and challenges. Held under the Chatham House Rule, we seek to engage participants in a candid and open debate in order to unpack the depth of engagement between Australia and the U.S., and shine light on contemporary challenges. We look forward to your active participation and lively discussion on how you seek to consider and shape the future of the U.S.-Australia alliance.

## SPEAKER BIOGRAPHIES



## THE HONOURABLE KIM BEAZLEY AC GOVERNOR OF WESTERN AUSTRALIA

The Honourable Kim Beazley AC was installed as the 33rd Governor of Western Australia. Mr Beazley was born in Subiaco, educated at Hollywood Senior High School and completed two degrees at The University of Western Australia. He served for nearly three decades in the Australian Federal Parliament and for a period of six years as Ambassador to the United States of America. Before becoming Governor, Mr Beazley had a distinguished record of service to the public, leadership and representation of Australia.

In 2009, Mr Beazley was awarded the Companion of the Order of Australia for service to the Parliament of Australia through contributions to the development of government policies in relation to defence and international relations, as an advocate for Indigenous people and for service to the community.

Mr Beazley was elected to the Federal Parliament in 1980 and represented the electorates of Swan (1980–96) and Brand (1996–2007). In the Hawke and Keating Labor Governments (1983–1996) Mr Beazley held, at various times, the portfolios of Defence; Finance; Transport and Communications; Employment, Education and Training; Aviation; and Special Minister of State.

From 1995 to 1996, Mr Beazley served as Deputy Prime Minister and Leader of the Australian Labor Party, and was Leader of the Opposition from 1996 to 2001, and 2005 to 2006. Mr Beazley served on parliamentary committees, including the Joint Intelligence Committee and the Joint Foreign Affairs, Defence and Trade Committee.

## MS MICHELE CLEMENT DIRECTOR, DEFENCE SCIENCE CENTRE

Michele Clement is the Director of the Western Australian Defence Science Centre (DSC) within the Department of Jobs, Tourism, Science and Innovation. The DSC aims to build strong collaborations across defence, universities and industry, facilitating defence-relevant research and technology connections that support defence and national security outcomes. It will support the commercialisation of defence-related research outcomes and cultivate an internationally engaged and competitive local defence industry.

Before this, Michele was the Director Innovative Science in the Department of Commerce, where she supported research and innovation, and promoted science and technology as major drivers of Western Australia's economic, social and environmental growth. Michele spent nine years working for the Commonwealth in the then Department of Innovation, Industry, Science, Research and Territory Education, undertaking both program delivery and policy roles. She also managed the Department's budget process, involving the securing of federal funding for a number of new programs and initiatives.

Michele has a background in banking and finance, particularly investment in small technology and biotechnology businesses. Michele holds a Master of Business Administration.





PROFESSOR PETER J. DEAN DIRECTOR, UWA DEFENCE AND SECURITY PROGRAM, THE UNIVERSITY OF WESTERN AUSTRALIA

Professor Peter J. Dean is Chair of Defence Studies, Director of the UWA Defence and Security Program, and a Senior Fellow at the Perth USAsia Centre. Prior to the commencement of this role Professor Dean was Pro Vice-Chancellor (Education) at UWA. He has been a Fulbright Professional Fellow and Endeavour Research Scholar in Australia-United States Alliance Studies, as well as a non-resident fellow with the Centre for Strategic and International Studies (CSIS) and the Australia, New Zealand and Pacific Studies at Georgetown University in Washington D.C.

Professor Dean was the founding editor of the Melbourne University Press Defence Studies Series, is a member of the Editorial Board of the Australian Army Journal, Global War Studies and the Military Studies Journal, and a former managing editor of the journal Security Challenges. An international award-winning author, his most recent book (with Brendan Taylor and Stephan Frühling) is After American Primacy: Imagining the Future of Australia's Defence, (Melbourne University Press, 2019).

### AIR COMMODORE FIONA DOWSE AM CSC

SENIOR MILITARY OFFICER IN WESTERN AUSTRALIA, **AUSTRALIAN DEFENCE FORCE** 

Air Commodore Fiona Dowse joined the Royal Australian Air Force in 1976. As a junior officer Air Commodore Dowse held various unit appointments managing civilian contractors providing aviation maintenance services to the Royal Australian Air Force and cargo and passenger air movements, working on large, complex exercise deployments supporting joint exercises.

Air Commodore Dowse has served as Staff Officer and was the Chief of Staff at Joint Movements Group, Headquarters Australian Theatre (now Joint Operations Centre). She has held a number of positions in logistics management and international engagement in Australia, United States and the United Kingdom, including a deployment to the Middle East as part of an investigation team.



Air Commodore Dowse was chosen as the inaugural Director of International Engagement - Air Force. On promotion to Air Commodore in November 2019, Air Commodore Dowse took up her current position as Senior Officer Western Australia.

Air Commodore Dowse was awarded a Conspicuous Service Cross in recognition of her work during the deployment of forces to East Timor, an United States Meritorious Service Medal for her work on the deployment of Implantation Forces to Bosnia, and was appointed as a Member of the Order of Australia (Military Division) for advancing the Royal Australian Air Force's standing among its allies through international engagement.







PROFESSOR GORDON FLAKE
CHIEF EXECUTIVE OFFICER, PERTH USASIA CENTRE,
THE UNIVERSITY OF WESTERN AUSTRALIA

Professor Gordon Flake is the founding CEO of the Perth USAsia Centre at The University of Western Australia. Having built an internationally recognised profile over 25 years of think-tank expertise and leadership in Washington DC, Professor Flake relocated to Perth in 2014 to establish the Centre, and to build a broader world-class Indo-Pacific strategic community. Before joining the Centre, he was the Executive Director of the Maureen and Mike Mansfield Foundation, a Senior Fellow and Associate Director of the Program on Conflict Resolution at The Atlantic Council of the United States, and prior to that Director for Research and Academic Affairs at the Korea Economic Institute of America.

Professor Flake is one of Australia's leading authorities on the Indo-Pacific, with a particular specialisation on Korea, having spent nearly three decades focused on the Korean Peninsula and Northeast Asia. He has edited several volumes and authored numerous chapters on developments in the region.

#### CONSUL GENERAL DAVID J. GAINER

U.S. CONSULATE GENERAL PERTH

David J. Gainer began his career as a U.S. Foreign Service Officer in Phnom Penh, Cambodia. He subsequently led Public Affairs endeavors at the U.S. Consulate in Chennai, India and the U.S. embassies in Prague, Czech Republic and Ankara, Turkey, where he was Spokesperson. He has focused on Australia twice in his career already – first as the Visas Chief at the U.S. Consulate in Melbourne, and more recently as the Deputy Director of the State Department's Office of Australia, New Zealand, and Pacific Island Affairs.

Before joining the Foreign Service, David taught budget and appropriation law classes for the U.S. Department of Treasury. He earned master's degrees in American History, African History, and Liberal Studies from the University of Maryland, University of Cape Town, and Georgetown University, respectively, and holds a BA in History from Xavier University in Cincinnati, Ohio. He taught secondary school as a Peace Corps volunteer in Malawi.





## THE HONOURABLE DAVID JOHNSTON AUSTRALIAN DEFENCE EXPORT ADVOCATE, AUSTRALIAN DEFENCE

The Honourable David Johnston was educated in Perth in Western Australia, David attended Wesley College from 1967–1973 and then graduated from The University of Western Australia in 1981 with the law degrees B.Juris and LLB. David was elected to the Australian Parliament as a Senator for Western Australia in 2001 and served in that role for 15 years.

Before that, he was a Barrister and Solicitor in Western Australia practicing in the areas of Mining and Crime, and lived and worked on the Eastern Goldfields of Western Australia for 12 years before returning to Perth to continue in the law and as a Barrister and In-House Counsel providing advice and representation mainly pertaining to mining matters in Western Australia.

In Parliament David was, inter alia, chair of the Senate Foreign Affairs Defence and Trade Committee, appointed by Prime Minister Howard as Minister for Justice and Customs in 2007, Opposition spokesperson as Shadow Minister on Minerals Energy and Tourism, and then Defence, from 2009 to 2013, and then Minister for Defence 2013 and 2014.

David has a strong commitment to the Australian defence industry and the current Australian Government's budgetary support of the Defence portfolio particularly focusing upon Australian naval ship and submarine building.

David is currently sitting on the Board of SAAB Technologies Australia, MCB Ltd (mining), International SOS (advisory board), The Centre for Defence Industry Capability (advisory board), The Australian Strategic Policy Institute (Council), Pelican Clean Energy Pty Ltd (LNG wholesaler) and is the Commonwealth's Advocate for Australian Defence Industry Exports.

#### MS BONNIE LIN

### MANAGING DIRECTOR OF THE RAINMAKERS GLOBAL AND A GENERAL PARTNER OF IDNEXT CAPITAL

Bonnie Lin is an independent advisor, investor and speaker with more than 20 years of international experience in commercial innovation, business development, strategic alliances and change leadership. Her background includes marketing for Silicon Valley dot coms, lean manufacturing in China and cross-border M&A and R&D grants under the Obama Administration during the Great Recession. Bonnie has worked with more than 70 entrepreneurs and business leaders to scale their organisations and transform their people in seven countries through three economic recessions. In addition to Fortune 500 projects and coaching Shark Tank startups, she has founded four businesses including a tech startup and real estate investment brokerage.

A Vancouver 40 Under 40 winner, Bonnie was a regular media contributor on entrepreneurship and innovation in the U.S.. She has served on the boards of the



U.S. District Export Council and Pacific Northwest Defence Coalition, and was a member of Keiretsu Forum angel investors in Seattle. Bonnie is the managing director of strategic advisory firm The Rainmakers Global and a general partner in iDNext Capital, a \$200-million Asia-backed venture capital fund in Silicon Valley. An advocate for entrepreneurship, social innovation, and women in leadership, she is a Board Trustee for the Fogarty Foundation and an Indo-Pacific Fellow for Perth U.S.Asia think-tank at UWA.

Bonnie is fluent in Mandarin Chinese and holds a BA from the University of California, Berkeley, an MBA from the University of Phoenix, and certificates in International Business from National Taiwan University, Venture Finance and Economics from UC Berkeley School of Law, and Value Investing from Columbia Business School.





**EXECUTIVE DIRECTOR, DEFENCE WEST** 

Matt is the inaugural Executive Director of Defence West.

He is a Walkley Award winner and an Australian Army Afghanistan veteran.

Matt has extensive knowledge of Defence, having experience as a senior adviser to the Minister for Defence Industry and Minister for Defence. He has worked on Defence's most complex and expensive projects over the past few years.

Matt was also a media adviser to Prime Minister Malcolm Turnbull. He deployed to Afghanistan as a public affairs officer in 2009 and East Timor in 2007. In a previous life, he was a journalist with the ABC and Network Ten.

#### MS NATALIE SAMBHI EXECUTIVE DIRECTOR AND FOUNDER, VERVE RESEARCH

Natalie is Founder and Executive Director of Verve Research, an independent research collective focused on the relationship between militaries and societies. Natalie is a PhD scholar at the Strategic and Defence Studies Centre, the Australian National University, focusing on Indonesian military history. In 2018, the Royal United Services Institute awarded her the Leo Mahony bursary to support her doctoral research.

From 2016 to 2020, Natalie was a Research Fellow at the Perth USAsia Centre. From 2012 to 2016, she also worked at the Australian Strategic Policy Institute (ASPI) as an Analyst and Managing Editor of ASPI's blog, The Strategist. She has previously worked at the Department of Defence, University of Canberra and for the academic journal Asian-Pacific Economic Literature. In May 2014 and in January 2016, Natalie was a Visiting Fellow at the Center for a New American Security (CNAS) in Washington, DC.



She holds a Bachelor of Arts (Asian Studies) (Hons) from The University of Western Australia and a Master of Arts (International Relations) and Master of Diplomacy from the Australian National University. Natalie has been a guest lecturer and presenter at the Australian National University, Australian National Security College, Australian War College, Indonesian National Resilience Institute (LEMHANNAS), Indonesian Defense University, Indonesian Ministry of Foreign Affairs, Canadian Department of National Defence and several international think tanks and universities. Her writing has appeared in Security Challenges journal, South China Morning Post, War On The Rocks, The Diplomat, The Interpreter and The National Interest.



## PROFESSOR STEPHEN SMITH CHAIR, UWA DEFENCE AND SECURITY PROGRAM, THE UNIVERSITY OF WESTERN AUSTRALIA

Professor Stephen Smith has been a Professor of Public International Law at The University of Western Australia since 2014. He is currently the Chairman of the UWA Defence and Security Program, Chairman of archTIS, Chairman of Sapien Cyber, Chair of the Advisory Board of the UWA Public Policy Institute, a member of the Board of the Perth USAsia Centre and a Member of the Board of the LNG Marine Fuel Institute.

Professor Smith was the federal member for Perth for the Australian Labor Party from March 1993 until September 2013. In a distinguished career spanning 20 years in the Australian Federal Parliament, Professor Smith served as the Minister for Defence, and prior to that, as Minister for Foreign Affairs and Minister for Trade. Following his retirement from the Australian Parliament in 2013, Professor Smith was a member of the EY (Ernst and Young) Oceania Government and Public Sector Advisory Board (2014–2017), Chair of the Asia Desk and a member of the Advisory Board of Perth Law firm Lavan (2014–2017), and a member of the Board of Hockey Australia (2013–2016).

Professor Smith completed his Bachelor of Arts and Bachelor of Laws at The University of Western Australia, and has practised as a Barrister and Solicitor in Perth. He completed a Master of Laws in Public International Law at London University, and subsequently lectured and tutored in Law in London.

## MR KYLE SPRINGER SENIOR ANALYST, PERTH USASIA CENTRE, THE UNIVERSITY OF WESTERN AUSTRALIA

Kyle Springer is Senior Analyst at the Perth USAsia Centre. He provides high-level program assistance and develops the think-tank and external outreach programs of the Centre. In addition to planning and coordinating a range of program and research initiatives, Kyle directs the Centre's Indonesia programs and convenes policy workshops focused on Australia-Indonesia relations.

Kyle was previously a researcher with the defence and foreign policy think tank, the Center for Strategic and International Studies (CSIS) in Washington, DC, and was a program assistant with Austrade at the Australian Embassy in Washington. While at CSIS he supported the research and programs of the Sumitro Chair for Southeast Asia Studies, working on a variety of subjects including economic reform in Vietnam, political developments in Cambodia, the Trans-Pacific Partnership, and the 2013 APEC meetings. He has written for blogs and e-newsletters like cogitAsia, Southeast Asia from Scott Circle, The Strategist and Australian Outlook.

In 2018, Kyle co-authored a chapter with Dr Jeffrey Wilson on Australia-Indonesia economic ties in *Expanding Horizons: Indonesia's Regional Engagement in the Indo-Pacific Era*. Kyle also authored "Vietnam as a G20 country: towards an Australia-Vietnam economic partnership," part of Perth USAsia Centre's Indo-Pacific 'Insights' Series. He has a Master in International Relations from The University of Western Australia (2012) and a Bachelor of Science from the California State University (2008).





DR JEFFREY WILSON
RESEARCH DIRECTOR, PERTH USASIA CENTRE,
THE UNIVERSITY OF WESTERN AUSTRALIA

Dr Jeffrey Wilson is the Research Director at the Perth USAsia Centre. He provides leadership and strategic direction in developing the Centre's research program across its publications, policy and dialogue activities. Dr Wilson specialises in the regional economic integration of the Indo-Pacific.
